Key points:

- Kitchen trailer build and installation was completed late 2023 acquitting the SSAA Grant of \$32K
- Need to compile a list of projects for new grant funding opportunities.
- Membership – 40 new members in 2023. Total membership increased to 240 from 235.
- Updates on the status on the action items from the 2023 AGM.
  - Coordination of training was undertaken with SSAA NSW
  - Workshop was conducted in March 2024
    - No recognition of prior experience for non-carded RO's, so we still have no RO Trainers
- Committee Meetings
  - Minimum of three allowed by the constitution.
  - Had three scheduled, two were conducted by video meeting.
  - Plan to schedule 6 meetings for the coming year subject to committee agreement.
- Working Bees
  - The club conducted **four** working bees in April, July, September and November 2023
  - Each pretty well attended with a number of maintenance tasks achieved including preparation for the SSAA NSW 2023 State Rifle Metallic Silhouette Titles

## General Business:

**Item 1:** Kyle Rowling – Can we have more rimfire pistol matches on the calendar, currently only 5 target matches and 5 silhouette matches?

Response – President advised that additional matches could be scheduled on existing match days and other options can be investigated.

Glenn Fletcher advised that the Cooma Range runs rimfire matches on the Saturday as well.

**Item 2:** Kyle Rowling – Can we arrange a club holster course?

Response – President advised that a holster course will be arranged for upcoming training days.

**Item 3:** Andrew Dunlop – It was mentioned that the range has Category C target approval?

Response – President advised there are special conditions associated with Category C target approval and will provide further information.

Update post AGM – Category C is restricted to Clay target shooting for competitors with a condition (requires written confirmation by GP) that requires a semi auto or pump action shotgun to compete.

**Item 4:** Andrew Dunlop – Could we look into the feasibility of turning targets for centrefire and Service Matches?

Response – Vice President advised that we have investigated pricing in the past and solutions can be expensive. President also discussed considerations such as storage and securing them from damage by cattle etc.

**Item 5:** Andrew Dunlop – Can we look at adding the 48 round Classic Service Match to the Calendar?

Response – Handgun Captain advised that we can investigate adding that match, we will need to obtain the rules and determine which governing body the match is under (SSAA or APA).

Update post AGM – Match is NSW APA. We may be able to vary the SSAA Combined Services Match to match configuration.

**Item 6:** Andrew Dunlop – As the range approvals are calibre based, can we use 45ACP in pistol matches?

Response – President advised that where the match governing bodies (eg IPSC, SSAA) have approved the use of a calibre in a match, and that calibre is on the range approval, then we would be able to use those calibres. Large calibre pistol permit only has two genuine reasons supported – Silhouette and Single Action.
